Re: New Chief Identifiers

Effective **January 1, 2015** at **0000 hrs** **ALL** Greene County Fire Chiefs' identifiers will change.

The reason why the identifiers are changing is due to several different reasons,

- The current system is antiquated and very hard to understand especially during large scale incidents.
- Unable to determine who the ranking Chief Officer is
- Too many different identifiers currently in use today
- Very confusing to a new Dispatcher
- Unable to create a standard County wide with current system in use.

The goals for the new Chief Officer identifiers are,

- Create a new standard that will work County wide
- Reduce the confusion within the 911 Center.

- Make the Communications and the 911 Center sound more professional during heighten times.
- Create something that will work with the current C.A.D (Computer Aided Dispatch) system.

After several meetings with a taskforce setup by Director Farrell consisting of members of the Fire Advisory Board, and the Fire Coordinators' Office it was determined to come up with a standard that will work Countywide. The standard that was agreed upon will follow the Greene County Standard Fire Radio Procedure which states there will be (1) Chief and (4) Assistant Chiefs.

The identifier for the Chief of the Department/Company will always be (NAME OF DEPT./COMPANY) CAR 1

Example: Oak Hill Durham Car 1.

The identifiers for the Assistant Chiefs will always be (NAME OF DEPT./COMPANY) CAR 2, CAR 3, CAR 4, and CAR 5.

Example: Palenville Car 2, New Baltimore Car 3, Hunter Car 4 & Greenville Car 5.

The identifiers for the Cause & Origin team and Hazmat team will follow the same format. (NAME OF THE ORGANIZATION) CAR 1.

Example: C&O Car 1, HAZMAT Car 1

The identifiers for the Assistant Chiefs if they have them will also follow the Assistant Chiefs format. (NAME OF THE ORGANIZATION) CAR 2.

Example: C&O Car 2, Hazmat Car 2

Below is what each designation stands for,

Car 1 will ALWAYS be the Chief of the Department/Company.

Car 2 will ALWAYS be the 1st Assistant Chief of the Department/Company

Car 3 will ALWAYS be the 2nd Assistant Chief of the Department/Company

Car 4 will ALWAYS be the 3rd Assistant Chief of the Department/Company

Car 5 will ALWAYS be the 4th Assistant Chief of the Department/Company

When a Chief or Assistant Chief uses a portable their identifier will remain the same. Chief Officers NO longer need to say PORTABLE 26-10 instead they will say Windham Car 1 no matter if they are using a mobile or portable.

The only ones to use the radio to report out of service (enroute), on scene (arriving) and in service (clear) WILL be the Chief Officers (Cars 1, 2, 3, 4 & 5).

By using the new Car 1, Car 2 etc. designators will make things easier in the 911 Center so the Dispatcher knows that Car 1 is always the Chief, Car 2 is the 1st Assistant Chief, etc... If a Department only has (2) Chiefs then said Department will only use Car 1 and Car 2. Also, this approved plan will make the fire ground operations run alot smoother and will work County wide.

NO NEED TO GO OUT AND CHANGE YOUR BI-LAWS THIS IS A COUNTY STANDARD

SOME EXAMPLES USING THE NEW FORMAT

Greene 911 Prattsville car 3 out of service/enroute.

Greene 911 to Palenville car 2.

Greene 911 East Durham car 1 in service.

Greene 911 Medway Grapeville car 4 on scene and command.

Greene 911 to Windham car 2

If a Department or Company has Company Officers (i.e. Captains, Lieutenants, Safety Officers) they will now also have a designated numbers to operate by. The designation for Company Officers will be the County identifier followed by either “10”, “11”, “20”, & “30” for Captain/Foreman, Lieutenants/Asst. Foreman. The designation of “40” will be for the Department or Company ISO (Incident Safety Officer).

Company Officers Captain, Lieutenants, Safety Officers etc. **SHALL** not call out of service (enroute/responding), on the scene (arriving) or back in service (clear).

For Greene 911 USE ONLY:

The way a Dispatcher will see the Chief units and fire equipment in the CAD will also change (see column labeled CHIEF UNITS IN CAD). **ALL** Chief units will have the first three letters of their Department followed by their respective number. All fire equipment will also have a standard displayed in the CAD. The way that ALL fire equipment will be displayed in the CAD will have no weigh bearing on the Department/Company. Fire equipment will follow the same format as the Chief units being the first three letters of the Dept./Company followed by the County ID, followed by the unit number
