As we noted in last year's annual report, the five year warranty on our election voting machines has expired and our next budget will reflect the cost of maintaining warranties on the election machines. The Commissioners discussed the issue of incrementally preparing to replace election equipment, and we will follow up this issue with Mr. Groden.

Some years ago we gifted the old election machines to the various school districts in Greene County. As parts and maintenance for the old lever machines become scarce we are receiving requests from our schools to use our current voting machines. We have accommodated these requests with a number of stipulations and most probably will see all school districts utilizing the new machines within the next year or two.

Various board personnel has, over the years, volunteered to assist local fire companies with their elections, and the Commissioners recently moderated a debate between candidates for fire chief in one of our communities. This type of activity, along with increased interaction with school districts will only increase. During the recent village election cycle we introduced an absentee scanner to facilitate the counting of absentee ballots. We continue to monitor and evaluate charges and improvements in election technology that serve to make our work more efficient and cost effective.

While our deputies continue that task of programming our election machines, thereby saving thousands of budget dollars, we are *engaging* our election clerks in an extensive training program so they will gain the ability to program the machines as well as accomplish a number of other associated tasks.

There are initiatives at the State and Federal level to have New York State join other states in offering early voting and same day registration. New York's Senator Schumer is in the forefront of those advocating for these changes. We will, through the NYS Board of Elections and the NYS Election Commissioners' Association continue to monitor updates relative to these issues.
