It Shall be the duty of the Financial Secretary to keep the names of the Delegate of each Company/ Department and keep attendance of said delegates and supply to the Chair of the Parade Rules and Regulations at the conclusion of the 4th Quarterly Meeting.

It Shall be the duty of the Recording Secretary to keep a record of the Organizations in attendance at each Quarterly Meetings and the Annual Meeting and supply the results to the Chair of the Parade Rules at the conclusion of the Annual Meeting.

It Shall be the Chair of the Christmas Party at the Fireman's Home, GCVFA Drill Day, GCVFA Day at the Fireman's Home, and the Youth Fair / Fire Prevention to keep record of each Organization in attendance of their respective events and supply a copy to the Chair of the Parade Rules Committee at the conclusion of each event.

If shall be the duty of the Parade Rules Committee to compile all the information and tally the number and award the Peter Bennett Memorial Award at the conclusion of each Annual Convention of the GCVA.
