## State News Updates

April 22, 2020

- **Governor Cuomo held a press conference at 11:30 AM and announced the following:**
  - Total hospitalizations dropped under 16,000 (15,559).
  - Net change in hospitalizations, new hospitalizations, and intubations all down.
  - Total deaths increased by 474 on April 21.
  - The Governor highlighted his belief that he had a productive visit with the President at the White House yesterday.
  - Testing, tracing, and isolating are the key to reopening.
    - **Former Mayor Michael Bloomberg has volunteered to develop the first-ever testing/tracing/isolation program.**
      - Johns Hopkins University and Vital Strategies will partner in this effort.
      - This will be a tri-state effort coordinated downstate.
      - Will work with SUNY and CUNY to draw from 35,000 students in medical field who can act as tracers.
- **The Department of Financial Services (DFS) will direct health insurers to provide cash flow relief to, and ease administrative burdens on, New York State hospitals in response to COVID -19**
  - DFS will direct insurers to:
    - Immediately process payments for outstanding hospital claims, work with hospitals in insurers' network to provide additional financial assistance if needed and feasible, suspend preauthorization requirements for all services performed at hospitals until June 18, not conduct retrospective reviews of hospital claims until June 18, and not make medical necessity denials related to emergency department and inpatient hospital treatment for COVID-19.

April 21, 2020

- **Governor Cuomo held a press conference at 7:15 PM to discuss his meeting with President Trump:**
  - Testing has been a very big task to undertake, and what role the federal and State governments play with regard to testing.
    - Need to go through the steps to determine which level of government is responsible for which steps.
    - State government should be responsible for managing the actual tests in their own laboratories, antibody tests, and contact tracing.
  - National manufacturers of the equipment who make the testing kits say there is a problem with the supply chains, and that is where the federal government can help.
    - States cannot do international supply chains.
    - 50 states should not be competing for international supply chains.
  - The President agreed with the Governor on the above points and will work to help with the supply chain issues.
  - New York does on average about 20,000 tests per day, goal is to double that number to 40,000 diagnostic and antibody tests per day.
    - That is current New York system at maximum capacity.
  - Also talked about funding to the States, and the President expressed his support for this funding in future legislation.
  - The Governor told the President the State would not be able to pay the local share for FEMA funding.
    - The President stated he will work to waive the local funding requirement.
