## State News Updates

April 6, 2020

- **Governor Cuomo held a press conference at 12:00 PM and provided the following information:**
  - **Extending NY PAUSE: schools and non-essential businesses are now closed until April 29:**
    - Increasing maximum fine for violations of State social distancing protocol from \$500 to \$1,000.
  - New York State will set up the COVID-19 First Responders Fund:
    - State Department of Health is accepting donations to be used for expenses associated with coronavirus first responders.
      - Blackstone is making a \$10 million contribution to the fund.

  - Total cases 130,689:
    - 16,837 currently hospitalized.
    - 4,504 ICU patients.
    - 13,366 patients discharged.
  - Total deaths 4,758, up from 4,159.
  - Number of new hospitalizations are down, number of ICU admissions are down, and change in daily intubations is down. Governor states these are all good signs.
  - The big question now is “where is the curve?”
    - Is it a plateau effect, or is it more of a peak with a precipitous drop?
      - Nobody knows
    - Projection models:
      - Initial projections stated we may need as many as 110,000 COVID beds towards the end of April.
      - Now models suggest we may be at the beginning of the apex at this moment, with needed beds well below that number.
    - Governor states if we are plateauing, we are plateauing at a high level, but we are plateauing because social distancing is working.
    - Continue to “surge and flex” the hospital system:
      - Moving 802 ventilators to needed locations (38 to Rockland County, 36 to Westchester County, 505 to New York City, and 223 to Long Island).
      - Relieve pressure by:
        - Javits Center: 2,500 COVID beds.
        - South Beach Psychiatric Center in Staten Island & Brooklyn Center Temporary Hospital will open this week specifically for COVID patients.
        - USNS Comfort: 1,000 beds, initially intended for non-COVID patients, but the Governor will request COVID use from the President.
        - These 3,500 beds would serve as a relief valve for downstate.
      - Northwell Health and US Military personnel will staff these beds.
  - Federal Government is going to increase the supply of hydroxychloroquine which would allow NYS to lift the 14-day limit on prescriptions.
    - No official data from a study on effectiveness, but there is anecdotal evidence that it is promising.

## State News Updates (continued)

April 6, 2020

- **The Board of Regents adopted emergency regulations related to the COVID-19 pandemic designed to provide flexibility for educators, students, professionals, and others.** **Highlights include:**
  - New York State received a one-year waiver from the provisions of the Every Student Succeeds Act (ESSA) pertaining to State assessments, and the Commissioner of Education will not conduct a review of school and district performance using 2019-20 school year data.
    - The accountability status of public schools and districts for the 2020-21 school year will remain the same as for the 2019-20 school year.
  - The State Department of Education will amend regulations to provide that an alternative form of evaluation for students receiving home instruction, in lieu of annual assessment, will be permitted for all grades in the 2019-20 school year.
  - Amends regulations to ensure public and private schools will not be penalized if they are unable to provide instruction for 180 days if schools were closed pursuant to an Executive Order of the Governor.
