Health Order of Mandatory Isolation of a Client Suspected of Having a Serious Communicable Disease

RE: Mandatory Isolation of _____

Reason for Health Order: Pursuant to Public Health Law Section 2100(2) and Section 2.29 of the New York State Sanitary Code (10A NYCRR §2.29), you have been diagnosed with **Coronavirus (COVID-19)**, a communicable disease that has the potential to adversely affect the health of the public.

Mandatory Isolation is for persons who tested positive for COVID-19 by a clinical test.

This Order is specific to:

- "Personal Quarantine" – Restricting household contacts and/or incidental household contacts to premises designated by the Local Health Officer.
- "Quarantine of Premises" –
 1. The prohibition of entrance into or exit from the premises, as designated by the Local Health Officer, where a case of communicable disease exists, of any person other than medical attendants and such other as may be authorized by the Local Health Officer; and
 2. Prohibition, without permission and instruction from the Local Health Officer, of the removal from such premises of any article liable to contamination with infective material through contact with the patient or with his secretions or excretions, unless such article has been disinfected.

Location: You are hereby directed to confine yourself at _____, County of Greene, State of New York, in order to prevent others from becoming ill.

Dates Health Order is in effect: This Isolation Health Order is in effect for the time period of _____ to _____, unless you have received further notice from the undersigned.

Treatment and evaluation is to be administered in accordance with the directives of the client's attending physician.

Review of this Health Order: The terms and conditions of this Health Order will be reviewed in **10 days**.

How to Appeal: You may appeal this Health Order to the Greene County Legislature by filing a written application for review within 10 days of receipt of this Health Order. If the appeal is denied, you may further appeal through commencement of an Article 78 proceeding in accordance within the New York State Civil Practice Law and Rules.


Notification regarding a Court Order: In addition to this Health Order, a Court Order may be obtained by this Department and enforced by law enforcement officials.

Consequences of Breaching the Order: A person who willfully violates or refuses or omits to comply with this order is guilty of a misdemeanor and may result in criminal prosecution under New York State Public Health Law Section §12(b).

Right to Legal Counsel: You have the right to obtain legal counsel, and to have counsel present during any court proceedings.
