



## Resolution No. 241-21

### Establish Capital Project # 118 - American Rescue Plan Act

WHEREAS, on March 11, 2021 the American Rescue Plan Act (ARPA) was signed in to law by the President of United States; and

WHEREAS, the objectives of this plan are:

- Support urgent COVID-19 response efforts to continue to decrease spread of the virus and bring the pandemic under control.
- Replace lost public sector revenue to strengthen support to vital public services and help retain jobs.
- Support immediate economic stabilization for households and businesses.
- Address systemic public health and economic challenges that have contributed to the unequal impact of the pandemic; and

WHEREAS, Eligible uses of these funds include:

- Costs associated with responding to the COVID-19 public health emergency or its negative economic impacts, including but not limited to, assistance to households, small businesses, and non-profit or aid to impacted industries such as tourism, travel, and hospitality.
- To support workers performing essential work during the COVID-19 public health emergency by providing premium pay to eligible workers or by providing grants to eligible employers that have eligible workers who perform essential work.
- To cover revenue losses caused by the COVID-19 public health emergency.
- To make necessary investments in water, sewer, or broadband infrastructure.
- Funds may **NOT** be used by states or localities to cover the costs of pension funds. States may **NOT** use funds to offset a reduction in taxes.

WHEREAS, Greene County was awarded \$9,165,716.00 from the ARPA funding; and

WHEREAS, THE Greene County Treasurer applied for the first installment and received \$4,582,855.00 on June 15<sup>th</sup>, 2021;

BE IT RESOLVED, that the Greene County Treasurer be authorized to establish Capital Project #118 American Rescue Plan Act in the amount of \$4,582,855.00 and to establish the following accounts:
