Annual Ag District Review – Requests for Inclusion

From October 1, 2022 through October 30, 2022 there will be a thirty (30) day open enrollment period during which any municipality whose territory is in Agricultural District No. 124, any State Agency or any landowner within or adjacent to the district may request an addition to the district. Any proposed addition(s) must be filed with the Greene County Department of Economic Development, Tourism & Planning, 411 Main Street, Catskill, N.Y. 12414 within the thirty (30) days specified. At the end of the thirty (30) day period, the Greene County Agricultural and Farmland Protection Board (AFPB) will meet to review the proposed additions. A public hearing will be held on the proposed additions and recommendations of the AFPB.
