GREENE COUNTY BOARD OF ELECTIONS

2022 Annual Report

The Greene County Board of Elections was challenged by several unique issues and much uncertainty in 2022. This required great flexibility on our part as we worked diligently to continue meeting our mandate to conduct fair and impartial elections in the most efficient and cost effective manner possible.

The first challenge we faced was the uncertainty surrounding the redistricting process for Congress, State Senate and State Assembly. Initial drafts submitted by the Independent Redistricting Commission had Greene County split into multiple districts in both the Senate and Assembly proposals. This was further complicated by delays in this process resulting in many areas of the state not even knowing who might be representing them in these various offices.

Fortunately, under the redistricting plan adopted by the State Legislature, Greene County was wholly within districts for Congress, State Senate and Assembly. While that was a positive step forward, it was derailed by litigation challenging the constitutionally of the plan enacted by the legislature. Ultimately, the State Courts ruled the redistricting done by the legislature for Congress and State Senate unconstitutional and a court master drew lines.

This action delayed and altered petition circulation timelines and submissions. It also resulted in two primary election cycles in New York rather than one. The originally scheduled June primary was conducted only for Statewide Offices and State Assembly. A second primary was scheduled for August for the delayed new Congressional and State Senate Districts.

While all of this was taking place, a vacancy was created in the 19th Congressional District when Anthony Delgado was appointed as Lt. Governor. This resulted in a Special Election being called by the Governor to fill the remaining 4 months of Congressman Delgado's term. This Special Election was scheduled to take place on the same day as the August Primary.

All of this proved to be extremely challenging for the BOE and, unfortunately, confusing to the voters of Greene County. Nonetheless, thanks to the dedication and commitment of our BOE staff, we successfully navigated all of this and professionally conducted a June Primary, an August Special Election and the November General election.

In addition to the above cited elections, the BOE conducted four village elections in March of 2022.

While the Board does not directly administer school district elections, we do work with our school districts in a cooperative fashion to facilitate those elections. We provide access to our voting machines which saves districts from having to purchase their own at a cost of \$12,000 to \$15,000 per machine. We also provide voter enrollment information and access to our trained election inspectors if a district so desires. At the end of the day, this saves our local taxpayers money.

The Board continues to implement numerous changes in State Election Law. Over the past few years this has included items such as:

- *The continuation of enhanced access to absentee voting.
- *Creation of a permanent Absentee Ballot Application transmittal system.
- *Complete overhaul for the canvasing of absentee ballots requiring review of such ballots within four days of receipt by the BOE.
- *Creation of an online absentee ballot tracking system.
- *Expansion of early voting hours required on weekends.

Without the support and assistance of so many others we would not be able to accomplish our responsibilities and mandate. Therefore, we wish to acknowledge:
