The incumbent works in the Family Planning Clinic and plays a vital role in providing comprehensive and specialized healthcare services to patients of all gender identities seeking information and or treatment for family planning, sexually transmitted infections (STI'S), and opioid use disorder. The employee functions as a clinical expert to deliver high-quality, evidence-based care to patients. The incumbent acts as a member of a multidisciplinary team that includes physicians, case managers, social workers, and other healthcare professionals to coordinate the health care of clinic patients. Work is performed under the general direction of the Family Planning Clinic Administrator and/or Clinic Manager. Does related work as required.

<u>FULL PERFORMANCE KNOWLEDGE, SKILLS, ABILITIES AND PERSONAL CHARACTERISTICS:</u> Thorough knowledge of the policies, practices, and procedures involved in family planning; Thorough knowledge of medical principles and practices as they relate to the role of Nurse Practitioner; Excellent knowledge and skills in providing women's reproductive health care; Ability to maintain records and make oral and written reports; Good powers of observation; Mental alertness; Tact; Courtesy; Physical condition commensurate with the demands of the position.
