PRESENTER MEGAN DEMENTO, Rural Outreach Program manager/Alzheimer's Association Specializes in rural areas Montgomery, Columbia

- Finances, prices of food and fuel continue to go up.
- Unfunded manadate for the home health aides has put a further strain on the department.
- Deputy Director and Executor Director are always meeting to crunch numbers and trying to keep spending level.
- Senior Angels generous donations DHS receives lists from DSS, nursing homes and case managers to provide Christmas gifts for seniors.
- Thanksgiving, collaboration with Community Action, could always use volunteers, will spend Wednesday prepping.

- Recognition, recap, did a great job, great times.
- Renaming of Helping Hands, has always been this name, should be find even if named Helping Hands of Greene County Department of Human Services. Started by the rotary years ago to assist with putting in air conditioner, changing light bulbs etc.

EXECUTIVE DIRECTOR'S REPORT:

- Open enrollment for Medicare.
- The threshold for Medicaid has increased, more people may be eligible.
- Heap applications are coming into the Department, we partner with DSS to assist older adults in the application process.
- Master Plan of Aging rolling out through New York State geared towards providing supportive services for Seniors. The Master Plan of Aging (MPA) is partnering with the Department of Health to provide access to in-home services and supports, partnering with public and private sector to find solution to combat social isolation, mitigate elder abuse, expand transportation and expand on aging services.
- T-Care is a new platform, assessment tool used for Caregiver's to provide resources and support.

Dick Golden: Fundraising for the food pantry, money and donations are coming in.

Linda Van Etten: discusses text message scams from Fed Ex, spoke to Fed Ex and they confirmed that they do not send out text messages.

Solutions to end homelessness and adhere to fair market rent, currently \$800-\$1,2000. For a one bedroom not, much is available now that it is getting colder, homelessness is a huge problem.
