<u>MINIMUM QUALIFICATIONS</u>: Graduation from high school or possession of a high school equivalency diploma and four (4) years of satisfactory experience and/or fire prevention work as a paid employee of a fire department or as a member in good standing of a volunteer fire company or department duly organized under the laws of New York State. Past or current Chief or Assistant Chief of a volunteer fire company or department.
